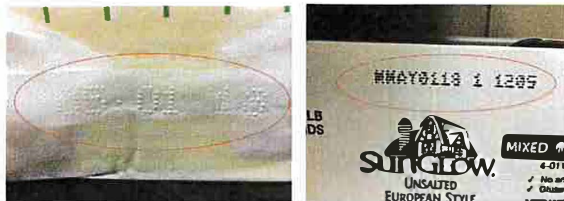
CWD has been notified that Ventura Foods has expanded their recent recall of Sunglow European Style Butter Blend products to include the following items:

CWD #66327 Butter Blend TFF Sunglow Euro Style Solid 36/1# (16842SNG)

CWD #60371 Butter Blend Ind Euro TFF (16836SNG)

The products were recalled because they contain trace amounts of an undeclared allergen, soy lecithin.

The affected lot numbers, that are located on the cardboard shipping case and embossed on the inner parchment wrap. Please refer to the chart on the following page for recalled product lot codes.



No other Ventura products or lot codes are involved in the current recall. To date, no illnesses related to this product have been reported. The trace amounts of soy lecithin contained in the product is not likely to cause adverse health consequences. However, people who have an allergy or severe sensitivity to soy run the risk of severe or life threatening allergic reaction if they consume this product. The recall was initiated after it was discovered that a product containing an undeclared allergen, soy lecithin, was distributed in packaging that did not indicate the presence of soy lecithin. Subsequent investigation indicates the problem was caused by a temporary breakdown in the company's production and packaging process. The error has since been corrected.

Re: Ventura Foods Recall – SunGlow Butter Blend Unsalted #16852-SNG (Expanded Recall)

CWD has been notified that Ventura Foods has expanded their November 2017 recall on the following product because it may contain undeclared soy lecithin (an allergen): **CWD #61893 – Butter Blend Unsalted TFF 16953 36/1 lb**
